1 What data do we collect?

Zeropoint collects the following data:

• Professional identification information (Name, email address, phone number, company, role, etc...)

2 How do we collect your data?

You directly provide Zeropoint with most of the data we collect. We collect data and process data when you:

- register online or place an order for any of our services;
- voluntarily complete a customer survey or provide feedback via email; or
- use or view our website via your browser's cookies.

Zeropoint may also receive your data indirectly from online sources such as public social media profiles or from third party partners.

3 How will we use your data?

Zeropoint collects your data so that we can:

- process and manage your order, subscription or contract; and
- email you with special offers on other products and services we think you might like.

Zeropoint does not share your data with partner companies so that they may offer you their products and services.

When Zeropoint processes your account, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent orders.

4 How do we store your data?

Zeropoint securely stores your data on self-hosted servers only and does not use public cloud infrastructure.

Zeropoint will keep your data for the duration of any contract plus five years. Once this time period has expired, we will delete your data by removing it from our databases.



5 Marketing

Zeropoint would like to send you information about products and services of ours that we think you might like, as well as those of our partner companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Zeropoint from contacting you for marketing purposes.

If you no longer wish to be contacted for marketing purposes, simply let us know.

6 What are your data protection rights?

Zeropoint would like to make sure you are fully aware of all of your data protection rights. Every contact is entitled to the following:

- The right to access You have the right to request Zeropoint for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification You have the right to request that Zeropoint correct any information you believe is inaccurate. You also have the right to request Zeropoint to complete the information you believe is incomplete.
- The right to erasure You have the right to request that Zeropoint erase your personal data, under certain conditions.
- The right to restrict processing You have the right to request that Zeropoint restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to Zeropoint's processing of your personal data, under certain conditions.
- The right to data portability You have the right to request that Zeropoint transfer the data that we have collected to another organization, or directly to you, under certain conditions.

There are a number of different types of cookies, however, our website uses:

- Functionality Zeropoint uses these cookies so that we recognize you on our website and remember you. A mix of first-party and third-party cookies are used.
- Advertising Zeropoint uses these cookies to collect information about your visit to
 our website, the content you viewed, the links you followed and information about
 your browser, device, and your IP address. Zeropoint sometimes shares some limited
 aspects of this data with third parties for advertising purposes. We may also share
 online data collected through cookies with our advertising partners. This means
 that when you visit another website, you may be shown advertising based on your
 browsing patterns on our website.

10 How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
